General Updates

- CVEP was honored with an Excellence in Economic Development Award for Fast Pitch Greater Palm Springs.

 The award was presented at the IEDC Annual Conference in Nashville during the first week of October. Media coverage of the award included an article in The Public Record and an interview on Radio 111.

- We are in the final stretch of planning for the 17th Annual Greater Palm Springs Summit. Recording will take place next week to allow ample time for post-production work. The Summit premieres on Thursday, November 18 at 9:00 a.m.
- We are simultaneously planning for the grand opening celebration of the **Palm Desert iHub**, in conjunction with CSUSB-PDC and the City of Palm Desert. The grand opening is to be held on the afternoon of Wednesday, November 17.
- **Responded** to four inquiries that came through CVEP.com.

iHub Updates

- Palm Desert iHub Administrative support is now on site from 9:30-3:30 daily. There are two iHub companies who will be using the space on a part-time basis: Palm Desert-based 3C.Health and Palm Desert-based NiftyFed. Entrepreneurship classes are being taught in the facility.

- Nine iHub companies are in the PCV business mentoring pipeline. Two have been matched with a mentor so far, a process which can take several weeks. We receive real-time updates via a shared data dashboard, and share updates and concerns in monthly check-in calls with the PCV staff. We have the option to expand this offering to the broader business community based on client feedback. To date, clients have been quick to sign up but slow to complete their full profiles.

CEO REPORT OCTOBER 20, 2021



CVEP Business Center Operations Operational Highlights September 2021

- 1. We have been working with Kay Hazen to prepare a series of discussions around moving CVEP to a financially sustainable revenue model.
- 2. CVEP has accepted an invitation to join the New Energy Nexus grant application to commercialize the "Lithium Valley" opportunities. The College of the Desert and CSUSB Center for Entrepreneurship were recommended by CVEP and have also accepted invitations to join this consortium. It will take an act of Congress to actualize this, but we are prepared to move fast with applications when there is clarity of opportunity.
- 3. P1CV has raised sufficient funds to support the continued effort to secure funds to expand the CSU Palm Desert Campus through the end of February. We have a chance to secure the funds we were seeking through a trailer bill in early 2022. Eight of the nine valley cities have now contributed to this effort.
- 4. We have not received a response from AAP regarding our second offer of compromise on the back rent in Building #12 at the Palm Springs Accelerator Campus. The non-eviction notice has expired, and we reach out weekly but have not gotten an answer. We will need to decide what to do about this in the near future.
- 5. CVEP is continuing in person staff meetings to discuss the future of the organization. The meetings are a quasi-SWOT analysis of the past, present and future with a goal of achieving a better path to long term sustainability.
- 6. Two iHub businesses have advanced to semi-finalist status for the 2021 Spirit of the Entrepreneur Awards.
- 7. Planning and securing sponsors for the 2021 CVEP Economic Summit is in the final 2 weeks. Our revenue goal is roughly at the 94% level. We have hired a temp for an assistant to Lesa and Laura to keep the Summit on track.
- 8. PD iHub facility officially has passed from the City of Palm Desert to CVEP and we have accepted our first client into the facility. Offices for Laura and Joe are setup for working.
- 9. In person meetings are now being held in all CVEP facilities with safety protocols compliant with the local jurisdictions of authority.
- 10. CVERT members have collectively decided to continue CVERT meetings. CVEP also continues to host monthly meetings of city and tribal ED directors to discuss challenges specific to those groups.
