Call to Order

The meeting was called to order at 8:03 am by Board Chair, Jan Harnik.

Welcome and Roll Call

Jan Harnik welcomed the board and attendance was noted.

Minutes

On a motion by Dick Oliphant, seconded by Oscar Ortiz, the minutes of the September 15th, 2021 meeting were approved as presented....all in favor.

Jan Harnik noted that the Executive Committee met via video conference. Operations and financials were reviewed and discussed – all in good order.

Member Updates

Oscar Ortiz mentioned that at the Indio Council meeting today, the fiber master plan and downtown development would be discussed and reviewed.

Jennifer Cusack noted that though SCE uses drones, they are not used at night. She also noted that they have fiber backbone in their transmission lines.



Deborah McGarry said that the Gas Company has some great developments with hydrogen blending to create a cleaner energy source.

Jan Harnik noted that there will be a celebration of the San Pablo corridor completion on October 23rd, 2021.

Randy Florence said that the Palm Desert Farmers Market is open now. He also announce that the PDACC breakfast on November 9th will feature Burrtec who will review the new recycling laws and that on Novmeber 10th the PDACC "refreshed" building would be open for tours, etc.

Rick Axelrod noted that LifeStream used the GIS services available at CVEP early on for identifying fixed site donor centers. He encouraged other board members to explore utilization of the GIS Services available to them.

He noted that blood donations are always needed and reminded the board that one donation helps to save three lives.

Roger Nunez said that the City of Desert Hot Springs will be holding its first annual Dia De Los Muertos celebration on November 6th, 2021. He also noted that their State of the City will be taking place tomorrow, October 21st, 2021.

General Updates

- Laura James will be serving on College of the Desert's new Business Advisory Committee under the Career and Technical Education program. The Advisory seeks to ensure that curricula prepare students adequately for entry-level positions and meet the needs of employers. Your insights are always welcome.
- The 17th Annual Greater Palm Springs Summit premiered on Thursday, November 18 at 9:00 a.m. We extend a
 huge THANK YOU to our sponsors and a very special thank you to Jerry Upham and his team at KESQ for their

- 383 registrants
- 357 views on YouTube
- One registrant drawn at random to win a new iPad, courtesy of **Hunter | Johnsen**. The winner was Jaime A., an **Indio** resident who works for **Grid Alternatives**.
- Content, program, and speakers all received at least a favorable 4/5 rating.
- Laura James will be presenting to a group of Canadian real estate investors in late January. A bus tour will be part of their trip. Are there spots they should visit within your city? Interested in multifamily (4-8 units); residential; small hotel, etc.
- **Responded** to six inquiries that came through CVEP.com (data requests; facility rental request; questions and comments about Summit; iHub inquiry).
- Wrapped up Year 1 of the SCE Wildfire Preparedness Grant program with Southern California Edison. The program cumulatively reached over 930,000 customers with vital public safety information. We have been invited to participate for a second year.
- Planning is fully underway for **Riverside County Innovation Month 2022**. CVEP is serving on the general Innovation Month planning committee, as well as the Fast Pitch/Events committee. Updates to follow.

iHub Updates

• Palm Desert iHub - CVEP was strongly encouraged to apply to participate in the Select USA CleanTech Inbound Investment Mission from February 15-17, 2022. This is a program to encourage and entice FDI from high-growth global clean-tech startups; FTZ and airport proximity are important factors in the application. We anticipate hearing back on our application status before the end of December.



BUSINESS SERVICES REPORT DECEMBER 15, 2021

- Palm Desert iHub Administrative support is on site from 9:30-3:30 daily. We have interviewed several companies that can manage room reservations online and are nearing a final selection. Two iHub companies continue to use the space on a part-time basis: Palm Desert-based 3C.Health and Palm Desert-based NiftyFed. NiftyFed is gaining traction with a lofty goal of making the Coachella Valley the NFT capital of the U.S. The Grand Opening was regarded as a success, and received good publicity.
- One new applicant; not admitted.

Intelligence Updates

- Five new **Data Digests** posted to CVEP.com (Non-primary residence study; 2020 Census tract population changes; 2020 Census population change, by city; New Coachella Valley Census tracts; COVID case rates, year-over-year).
- Commissioned by **Visit Greater Palm Springs**, **David Robinson** analyzed local Riverside County property data to complete the study Non-Primary Residences by Location of Owner. The study provides insights about the owners of second (or third or fourth) homes, long-term rentals, short-term rentals, and the like.





Do you think that the leaders of the Coachella Valley should establish a sustainable funding stream for regional economic development?







CEO REPORT DECEMBER 15, 2021



CVEP Business Center Operations Operational Highlights November 2021

1. The executive committee is working to move toward a listening tour during the first few months of 2022 as part of a CVEP Sustainable Funding plan.

2. The New Energy Nexus grant application that includes CVEP as an intellectual property generator did not make the cut of the final sixty applicants. The funding is to come from the Build Back Better bill that has not been passed into law.

3. P1CV has raised sufficient funds to support the continued effort to secure funds to expand the CSU Palm Desert Campus through the end of February. It is abundantly clear that without some outside funding CSU has no plans to physically expand the Palm Desert Campus.

4. CVEP and Visit GPS have completed a GIS based study of the non-primary (snowbird) residences in the Coachella Valley. There are roughly 70,000 such residences.

5. Joe provided consultive assistance to the Palm Springs Planning Commission at their request on the values and challenges of attracting warehouses to the part of the City of Palm Springs on the north side of Interstate 10.

6. Four companies have begun using the Palm Desert iHub as clients.

7. The Summit survey has provided valuable input on the subjects of funding and actions in regional economic development that the respondents support.

8. Building #12 at the Palm Springs Accelerator Campus should be available to entrepreneurs early in 2022. Building #9 has a new client moving in to 25% of the space starting January 1, 2022.

9. Patty Clouser is retiring from CVEP effective December 31, 2021, after more than 10 years of service. She is looking forward to spending more time with her family.

10. I would appreciate it very much if any of you can make suggestions for the kinds of subjects that you would like to see at future board meetings.

11. CVEP has served as the speaker at the Palm Desert and Indio Rotary Clubs since the Summit.

BUDGET NEWS AND PROJECTIONS:

The City of Indio reduced support by \$50,000 from \$75,000 that was budgeted, to \$25,000. This combined with a similar action by Palm Springs reduces general support from public sources by \$100,000 to \$205,000 for the current fiscal year.

Pacific Western Bank reached out to sponsor CVEP with an additional \$10,000 this calendar year.

We have taken actions to save approximately \$30,000 in expenses through the remainder of the FY and secured \$20,000 in sponsorships that were not budgeted.
