Call to Order

The meeting was called to order at 8:03 a.m. by Board Chair, Jan Harnik.

Welcome and Roll Call

Jan Harnik welcomed the board and attendance was noted. Jan asked two new board representatives to introduce themselves – Dr. Christina Tafoya from COD and Tracy Tremblay from Pacific Western Bank.

Minutes

On a motion by Deborah McGarrey, seconded by Phil Smith, the minutes of the February 16th, 2022 meeting were approved as presented....all in favor.

Executive Committee

Todd Hooks noted that the Executive Committee met via video conference. Operations and financials were reviewed and discussed – all in good order. He reviewed the results of the first industry roundtable [banking] with the board – unanimous amongst attendees was the lack of "soft skills" in prospective employees, amongst other challenges. Discussion followed.

Jan Harnik responded that was possible and said that CVEP used to hold their board meetings across the valley in investor cities. Roger Nunez from the City of Desert Hot Springs offered to host the next meeting at their new City Hall building.

CEO REPORT APRIL 20, 2022

CVEP Business Center Operations Operational Highlights April 2022

1. The executive committee and staff embarked on a listening tour during February as part of a CVEP Sustainable Funding plan. Our second business sector was healthcare. Their main concerns expressed were staffing and soft skills. One executive expressed support for economic development being more regional.

2. P1CV has made encouraging progress in gaining critical support for the \$80M request to build a student success center on the Palm Desert Campus of CSUSB. The educational agenda for the current state budget discussions are set for 5/22 with a second milestone for possible approval in mid-May. Drop dead date for success is 8/31/2022. A press conference will be held at the PDC Friday 4/22 at 9:00 a.m.

3. CVEP is starting to schedule office hours for staff on an as-needed or made-available basis starting May 1.

4. CVEP's meeting with the Riverside County EDA to discuss what should be done to optimize outcomes in economic development is pending.

5. CVEP met with JP Morgan Chase representative to discuss partnering and investments to further internal DEI goals established by Jamie Dimon, CEO.

6. CVEP one-pager draft is developed and included for review.

7. LifeID (eTagz) was judged to have the best Fast Pitch at the Coachella Valley Fast Pitch Contest. The entrepreneur has advised us that he will not participate in the Riverside County Fast Pitch Finale event.

8. Joe Wallace and Jan Harnik served as panelists on higher education and job preparation in the CSU IT Tech Talks.

9. CVEP has been named to the IEGO Coordinating Council to assist with the State of California planning process for the greater Inland Empire Region. The initial allocation for the study will be \$5M for the Riverside/San Bernardino MSA.

10. We are continuing to monitor the reports on inflation and wage growth for use in forming a budget for FY 22-23.

11. Agreement reached to clear out Building #12 and part of #9.

CVEP ACCOMPLISHMENTS: DRAFT

The Coachella Valley Economic Partnership (CVEP) was established in 1994 with the mission to further efforts to diversify the economy of the Coachella Valley into business sectors that pay thriving wages and are not dependent on our legacy hospitality industry. In 2011, the mission became more focused on entrepreneurship with the State of California's establishment of the Innovation Hub program. Today CVEP manages three iHubs in the region, offers analytical services, provides consulting services, and charts a course for a future of prosperity. Since refocusing efforts in 2011, a partial list of CVEP's accomplishments include the following:

Entrepreneurship: CVEP was selected as the operator of one of the original six innovation hubs (iHubs) in the State of California. Since beginning in 2012 in the CVEP headquarters in Palm Springs the iHub program has expanded to include an Accelerator Campus, a Palm Desert Digital iHub and a pilot iHub in Indio. The start-up count is approaching 100 businesses with 26 still in the program. Thirty-seven (37) companies have graduated from the program with 23 patents awarded, over \$30 million in venture capital raised and just over 200 jobs created. Companies from the iHub program have won seven (7) Sprit of the Entrepreneur Awards from CSUSB and three of the four Riverside County Innovation Month champions. The iHub program is considered the best entrepreneurial ecosystem in the San Bernardino- Riverside MSA and has won many honors for excellence.

Business Support: CVEP has been entrepreneurial in seeking ways to help local businesses. Our series of seminars on topics from financial literacy, operations, marketing and social media strategies have assisted businesses from across the Coachella Valley. CVEP has furthermore formed partnerships with other business support entities like banks, SCORE and the SBDC to assist businesses of all sizes and sectors in improving their operations.

Vision 2050: In 2018 after reviewing the request for proposal for the Amazon HQ2, CVEP realized that the Coachella Valley was not a serious contender for such projects. Upon this realization we embarked on a mission to bring together the leaders of the Coachella Valley on critical infrastructure needs such as state-of-the-art bandwidth, a vibrant local investment community, and a comprehensive four-year university.

Educational Advancement: CVEP partnered with the City of Palm Desert and Visit Greater Palm Springs to form Priority One Coachella Valley (P1CV) as a 501c4 to lobby for the State of California to expand the CSUSB Palm Desert Campus. We will learn in the next 5 months if we have successfully secured funding for a Student Success Center for the Palm Desert Campus. A student center is vital to the college experience: it will provide both health and food services along with other facility-related needs to provide the platform for an excellent college experience for Coachella Valley students.

CVEP's efforts were influential in the decision of CSUSB to offer programs in cybersecurity and entrepreneurship in the Palm Desert iHub adjacent to the campus.

Analytical Services: CVEP has a geographic information systems (GIS) professional on staff who regularly conducts analysis on economic trends that impact the Coachella Valley. The study that inspired the effort to seek funding from the State of California to expand the Palm Desert Campus originated in CVEP. Other timely studies have included workforce and business impacts due to the pandemic and various other topics of local economic interest.



Consulting Services: CVEP has served as consultants to local municipalities in projects like development of a fiveyear economic development plans and responding to warehouse opportunities. CVEP also holds a monthly meeting of city & tribal economic development directors to learn what their current priorities and areas of interest are.

COVID19 Responses: In response to the pandemic, CVEP redirected its efforts to assist Coachella Valley-based businesses of any size as they sought financial relief from federal, state, and local jurisdictions and then securing forgiveness from PPP and other loan programs. Our efforts literally helped bring tens of millions of dollars into the Coachella Valley at a critical time. In addition, CVEP sought and was awarded \$3 million worth of Personal Protective Equipment (PPE) to the businesses, non-profits and humanitarian agencies across the Coachella Valley.

Telecommuter Attraction: At the CVEP Economic Summit in 2019, CVEP announced the launch of a digital and social media-based telecommuter attraction campaign. Our messaging was seen by thousands of people from urban technology centers. The wealth created just from the increase in housing prices since the pandemic helped inspire telecommuters to relocate now exceeds \$50 Billion. The attraction of educated professionals who telecommute increases our critical metrics of educational attainment, disposable income, and workforce availability.

National Affiliations: CVEP was named as a charter channel partner of the IN2 partnership between Wells Fargo Bank and the National Renewable Energy Lab (NREL) and is an active participant in the program. CVEP was recently called upon by Breakthrough Energy (climate change initiative of Gate Foundation and others) to assist in the evaluation of proposals designed to mitigate over 50 million tons of CO2 emissions each year.

Laura James, CVEP's vice president of innovation, earned the designation of Certified Economic Developer (CEcD), the International Economic Development Council's recognition that denotes a mastery of skills in economic development, professional attainment, and a commitment to personal and professional growth. James is the only Certified Economic Developer in the Coachella Valley.

Awards: CSUSB Spirit of the Entrepreneur Awards (7), Martin Luther King Legacy of Service Award, Lifestream Humanitarian Award, South Coast Air Quality District Clean Air Award, International Economic Development Council Excellence Awards (3), Multiple Addy Awards, and numerous citations from the State of California.
